

TERMS AND CONDITIONS FOR THE VILLAGE SHOPPING CENTRE'S "DIGITAL CHRISTMAS TREE" PROMOTION

Information on how to enter and prizes form part of these Terms and Conditions. Participation in the "DIGITAL CHRISTMAS TREE" Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.

WHO CAN ENTER?

1. This Promotion is only open to South East Queensland Residents, 18 years old or over at the time of entry. If you are not 18 the prize will be awarded to your parent or guardian.
2. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers in THE VILLAGE Shopping Centre or any of the Promoter's agencies or suppliers that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

3. This Promotion commences at 7:00am on Thursday 19 November 2020 and ends at 5.00pm on Thursday 24 December 2020. ("Promotion Period"). Entries received after this closing time will not be eligible for entry.

HOW TO ENTER

 - Enter required contact details including a valid mobile number.

PRIZE DETAILS

5. There are various gift cards/vouchers and other prizes available. Total value \$1500 available.

ENTRIES

6. One entry per day per person is permitted.

INVALID ENTRIES

7. The following entries are not valid entries for the purpose of the Promotion: (a) photographs not uploaded via the Interlike App; (b) photographs shared on Facebook and Instagram outside of the promotional period.

WINNER NOTIFICATION

Each random winner will be notified via text message using the number entered into the Interlike App. To claim their prize, the winner will need to present to THE VILLAGE Centre Management on Level 1 with the text message and proof of identification within the promotional period. A prize declaration form will be required to be filled in to confirm that you've claimed your prize.

ADDITIONAL TERMS AND CONDITIONS

9. Prizes are not transferable, changeable or redeemable for cash.
10. Once awarded, the Promoter is not liable for any prize that has been lost, stolen, forged, damaged or tampered with in any way.

The time receipts are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.
